## SCOPE

UPSIC has already registered manpower outsourcing vendors, to fulfil the demand from various Government agencies. It has been decided to create a bidding process for allotment of work.

### 5. EVALUATION PROCESS: -

The evaluation of Technical Bid will be done as follows -

In the format of Technical Bid: -

(a) Sl. No. - 1, 2,3,4 are mandatory and anybody who fails to provide the related documents (photocopies), their bids will be rejected.

(b) Sl. No. -5,6,7,8 carries marks as mentioned in marks column in the format.

(c) Total marks allotted in the Technical Bid & Financial Bid are 70 and 30 respectively. Financial bid of those parties will be opened who have secured atleast 50 marks & above in Technical Bid and weightage for Technical Bid and Financial Bid shall be 70% and 30% respectively at the time of final selection.
